Agreement and Indemnification

Upon completion, execution and acceptance of this agreement, Abby's Organic Community Farm, Inc. is granting limited access and use of our farm. As such, the access and use is contingent upon compliance with strict guidelines and rules related to the farm property that may be posted and include, but not be limited to: The time and day accessed; The prohibited use and access to certain

areas and equipment; Items, materials and substances that will be prohibited on the farm that could compromise our “Organic” farm and mission. The guidelines and rules may change from time to time, and will be communicated to all volunteers and visitors and posted at the farm regularly.

It is understood by virtue of being granted access to volunteer, work or visit the farm property, I agree to indemnify and hold harmless Abby’s Organic Community Farm, Inc., the employees, officers, and directors, successors, heirs and assigns; for any accident or incident that results in any form of personal injury, including death. It is hereby acknowledged that the farm work and area is generally outdoors and thus subject to extreme temperatures; requires certain strenuous and demanding physical abilities; and that the equipment and material used in and around the farm, by their very nature, are dangerous and require extreme caution.

I acknowledge this indemnification and hold harmless agreement shall include myself, any guests/invitee or minor children that may accompany me while on the farm property.

I agree and understand that while I am on the property pictures may be taken at any time for use on our website, Facebook page, newsletter, educational productions, etc., and as such I hereby consent for that reproduction to be used for that purpose. Furthermore, any and all literature, brochures, media, educational, training material and/or intellectual property of any kind that I may be a part of producing or that I may produce in whole or in part, shall be the permanent and absolute property of Abby’s Organic Community Farm, Inc.

It is understood that when volunteering to be a part of educational classes that involve children, I may be required to comply with the state requirements related to fingerprinting and a criminal background check.

By submitting this application, I affirm that the facts set forth in it are true and complete. I understand that if I am accepted as a volunteer or given access, any false statements, omissions, or other misrepresentations made by me on this application may result in my immediate dismissal or refused admittance. Additionally, I acknowledge and understand that my use and access to the farm is at-will and can be withheld or revoked at any time for lack of compliance with stated guidelines and rules.
